Dear LSU Law Students:

LSU has provided us a message and links for distribution to all our students, both incoming and returning. It addresses the manner in which you will demonstrate your compliance with the requirement to prove your vaccination status, negative test status, etc. That message is below. Please continue to watch your email carefully, as we may have additional information for you on this and other topics related to the start of school.

Please note that we have reached out to the administration, and they understand that the Law Center semester timeline does not follow the same schedule as most other units on main campus. Because our program begins earlier, you should disregard the later (August 22) deadline in the LSU EOC message below and upload your vaccination or test documentation as soon as possible (as also noted in the email below).

We are looking forward to a great academic year with all of you.

Dear Students,

In order to comply with the COVID-19 Fall 2021 entry protocols, all LSU students will need to provide one of the following items prior to arriving on campus for the Fall 2021 semester:

- Proof of a negative COVID-19 test result **no more than 5 days prior to your arrival on campus**
- Proof of COVID-19 vaccination
- Proof of a positive COVID-19 test result **no more than 90 days prior to your arrival on campus**

This is required of all LSU undergraduate and graduate students appearing on campus or participating in on-campus activities, whether living on or off campus, including those living in Greek housing, students of the Paul M. Hebert Law Center, and students of the School of Veterinary Medicine.

To show compliance with entry protocols, students must access the Fall 2021 COVID-19 Entry Test [Verification Portal](#) and upload appropriate documentation.

Documentation should be complete, legible, and meet the time periods detailed above

for test results. ***Please note, if you are already on campus, be sure to complete this verification as soon as possible.***

Free COVID-19 testing and vaccinations are available on campus at the LSU Student Union Theater. Vaccines are available at this site Tuesday-Saturday from 10 a.m. to 4 p.m., and testing is available at this site weekdays from 9 a.m. to 4 p.m. Vaccinations are also available at the LSU Student Health Center during the center's Injection Clinic regular hours. Appointments are not necessary at the Union Theater or the Student Health Center. Students outside the Baton Rouge area can find vaccine locations in their cities and states at <https://www.vaccines.gov/>. We strongly encourage all students to get vaccinated. The vaccine is free and, according to the CDC, it is safe, effective and provides protection against variants of the virus. The vaccine is also the way that we can return to a more normal college experience for our students.

The deadline for submission for all LSU students is 11:59 PM on August 22, 2021.

Thank you for doing your part to keep our campus community safe. The health and safety of the LSU community is of the utmost importance to us.
